Pinal County launches new effort to curb illegal dumping

FLORENCE - A new rewards program will provide a monetary incentive for residents to submit tips and information on those illegally dumping items in the desert as part of a revamped effort to curb the issue across Pinal County.

Pinal County is a beautiful place to live, work and play. However, the amount of tires, mattresses and other items littered across the desert is unacceptable and an eyesore. The Pinal County Attorney's Office is launching a 'rewards program' that will provide a \$500 reward to tipsters who submit information on people illegally dumping items if the tip leads to charges in the case.

"This is a problem that we need the whole community to help us solve," said Pinal County Attorney Kent Volkmer.

Pinal County has also created a new, simplified online page to direct residents to any resource they are seeking. This includes how to properly dispose of bulky items, when and where to find community cleanups, and how to report an illegal dump site.

"We wanted a one stop shop with all the information that people would need to do the right thing," Volkmer said. "We are really excited and hopeful that this new program is going to cut down on illegal dumping and hold those that do dump accountable."

The new online site, which includes the submission form for the rewards program, officially launched Wednesday, Dec. 8.

"There's no longer the excuse of, 'I didn't know what to do with it," Volkmer said. "All of the information is now at the end of your fingertips."

Superior Rotary places Peace Pole at Besich Park

December 7 of this year marked the 80th anniversary of Pearl Harbor. The U. S. Navy, along with the National Park Service, hosted varied ceremonies in Hawaii on that day, as well as the day before and after, in memory of the day, including memorializing the USS Nevada, Utah and Oklahoma.

Three-hundred sixty-five Japanese bombers attacked Pearl Harbor and also Ford Island Naval Air Station base in Oahu, Hawaii, beginning shortly before 8 a.m. By 8 a.m., they had bombed Wheeler Army Airfield, injuring 53 people and killing 37 soldiers, while devastating the base by bombing aircraft hangers and airstrips, destroying 54 planes. This was just the beginning of their reign of terror and destruction on an unsuspecting populace.

The attack, intended to cripple the Pacific Fleet, lasted approximately 115 minutes. While the Japanese intended this attack to prevent the United States from taking action against them regarding

their dealings with Southeast Asia, America was, on that day, launched into World War II.


One of the battleships that were sunk that day, when 2,403 serviceman and civilians were killed and 1,178 were injured, was the USS Arizona where 1, 177 sailors and marines remained on board and were taken to their watery grave. On December 6 of this year, Channel 8 featured the interment of the ashes of a Mr. Marino who served on the USS Arizona 80 years ago.

This attack, this bloody and awful day, is referred to simply as Pearl Harbor, the name of a once peaceful place on an island that encouraged thoughts of paradise. Regardless of what the days are like at Pearl Harbor in modern times, the name is burnt onto the hearts of those who survived, those who were or are related to the survivors and all Americans who believe in learning from history in order not to repeat it.

Dear Santa ...

Christmas is coming. It will be here ever so soon. In every land, every country, every city or town or village - really, anyplace you can find on a map and many places that you cannot - children have written their holiday missives, expressing their heart's desires and are anxiously awaiting a Christmas visit from Santa.

The United States Postal Service site states, "Each year, hundreds of thousands of letters sent to Santa from children and families arrive at Post Offices around the country. Most letters ask for toys and games. Some ask for basic necessities. Some ask for help for themselves and their loved ones."

For as long as children have been sending letters to Santa, he has cherished these communications and shared them with his wife. In December of 1899, Santa decided to share a letter to be printed in a newspaper. The letter was quite simple. In it an unnamed girl said, "Dear Santa, If you haven't time to pick out things for me, just leave everything you've got."

The very next year, many more letters to Santa were printed in the same newspaper. A tradition was born. Though Santa has never explained the reason he started sharing the letters he receives and allows them to be printed, there are many theories which he has equally never denied as possibilities.

The chief theory is that with the increased population of the world, Santa was using this method of communication to seek out new helpers. Another theory, somewhat less likely to apply in all situations, is that the newspaper editor had been a very good boy or girl in their youth and Santa felt they deserved an extra present.



suffering and destruction of families and their communities in war and personal and community conflict."






