“We did not come out ready to play,” coach Manuel Ortega commented.

The boys struggled to hit against the Bearcats, only getting five hits during the whole game. The players who were able to hit against Ray were Jared Toner, Ally Hing, Adam Navarrette, Nathan Duarte and Josh Marquez, with Marquez being the only player to score a run. Matthew Cruz pitched three strikeouts for the game. Adam Navarrette also pitched, getting two strikeouts. The game ended with a final score of 1-16.

“Ray was ready and they put a really good whooping on us,” coach Ortega stated, “The main question after this game is; how do we respond? What are we made of?”

The Panthers will have the chance to

show what they’re made of when they rematch Ray on Monday April 26, followed by San Manuel on April 30.

The Panthers softball team played another two games over the past week. Their first game of the week was on April 20, at home, where they faced off against Antelope. Mikayla Cruz went 2-2, with an inside the park home run and a double, scoring twice. McKenna Duarte also hit a double, bringing in a run. **A RESOLUTION OF THE MAYOR AND COUNCIL OF THE TOWN OF SUPERIOR, ARIZONA, DECLARING AS PUBLIC RECORDS THOSE CERTAIN DOCUMENTS FILED WITH THE TOWN CLERK AND ENTITLED EXEMPTIONS FOR SINGLE FAMILY RESIDENTIAL DWELLINGS AND MANUFACTURED /MOBILE HOMES**  
**RECITALS:** WHEREAS, Arizona Revised Statutes §9-802 provides for the adoption of a code or public record by reference; and WHEREAS, The Town Council has determined the adoption by reference the Town Code Article 12-3-4 Exemptions for Single Family Residential Dwellings and Manufactured/Mobile Homes will be beneficial to the health, safety and welfare of its citizens; and WHEREAS, it is the purpose of this Resolution to declare the Town Code Article 12-3-4 Exemptions for Single Family Residential Dwellings and Manufactured/Mobile Homes to the International Residential Code 2018 in the Town of Superior, Arizona; to be public records for the purpose of adoption by reference; and **ENACTMENTS: Article 12-3-4 Exemptions for Single Family Residential Dwellings and Manufactured/Mobile Homes** A. Building Permit Required 1. It shall be unlawful to erect, construct, reconstruct, alter or use any structure or building without first obtaining a building permit from the Town of Superior; except that no building/use permit shall be required for any repairs or improvements of a value not exceeding \$1,500 dollars (market value labor and materials or actual receipts for cost of materials can be provided) except that those items listed in this section below are completely exempted from permit requirements for single family residential dwellings and manufactured/mobile homes. 2. For non-residential uses a permit is required regardless of the dollar value of the improvement when there are applicable building code requirements. 3. For the purpose of determining the value of any such repair, alterations, or improvements, the normal retail value of materials and labor performed shall be used. Even though no permit is required for repairs or improvements having a certain value or listed below, such repairs, improvements, or alterations shall comply with all other provisions of IRC2018 4. Re-establishment of a discontinued non-residential use shall not require a permit for the same use, provided that the discontinued use was established through the permitting process in place at the time of establishment, and that no new construction is proposed. B. Work Exempt from permit for Single Family Residential Dwelling and Manufactured/Mobile Home Only. 1. Re-roofing (when no structural changes are proposed or any reinforcement is required to add heavier roofing materials), re-siding or replacement of exterior trim. 2. Replacing or adding gutters or downspouts. 3. Replacing or adding soffit, gable, or roof ventilation. 4. Replacing existing windows or doors with no structural changes. 5.

### Public Notice

Decks less than 30-inches in height above the lowest grade within 5-feet of deck edge. 6. Replacing like for like or repairing existing plumbing fixtures such as toilet, tub, sink, garbage disposal, water heater, or faucets. 7. Replacing existing appliances or internal light fixtures. 8. Replacing like for like or repairing existing furnace, air-conditioner, cooler, heat pump, or heater. 9. General landscaping including lawn sprinkler systems, subject to water conservation requirements, and retaining walls up to 4-feet in height. 10. Installation of low-voltage wiring for security alarm systems. 11. Flooring of wood, vinyl, ceramic, stone, masonry or carpeting. 12. Installation or removal of non-structural interior wall partitions if no utilities are involved. 13. Adding or replacing insulation in walls, floors or ceilings. 14. Wood, concrete block or wire fences up to six-feet high. If any of the following applies as permit is required: a) Located on a corner lot and greater than 3 feet in height; b) Located within a designated FEMA Flood Hazard Area; c) Located within a designated wash. 15. Painting, interior or exterior, and wallpapering. 16. Concrete walkways, not in Town right-of-way, and patio slabs. 17. Replacing cabinets or countertops. 18. Window awnings supported by an exterior wall which do not project more than 54-inches. 19. Swings and other playground equipment accessory to a single family dwelling. 20. DECLARATION OF THE MAYOR AND TOWN COUNCIL OF THE TOWN OF SUPERIOR, ARIZONA, DECLARING A TOWN STATE OF EMERGENCY WHEREAS the World Health Organization declared a Public Health Emergency of International Concern on January 30, 2020, the United States Department of Health and Human Services declared a Public Health Emergency related to the COVID-19 outbreak on January 31, 2020, and the World Health Organization officially declared a pandemic due to COVID-19 on March 11, 2020, and the Governor of Arizona declared an emergency due to COVID-19 and issued Executive Order 2020-07 providing Proactive Measures to Protect Against COVID-19; and WHEREAS, on March 12, 2020, March 20, 2020 and June 18, 2020 the Mayor of Superior issued Declarations declaring health emergencies in the Town of Superior to address COVID-19; and WHEREAS, on June 17, 2020 the Governor issued Executive Order 2020-40 allowing for the Town of Superior to adopt policies regarding the wearing of face coverings in public for the purpose of mitigating the spread of COVID-19; and WHEREAS, on March 25, 2021 the Governor issued Executive Order 2021-06 allowing for the Town of Superior to continue policies regarding the wearing of face coverings in public buildings for the purpose of mitigating the spread of COVID-19; and WHEREAS it is necessary and appropriate to take action to ensure the spread of COVID-19 is controlled and that the residents of the Town of Superior remain safe and healthy; and WHEREAS the Mayor of the Town of Superior is authorized by the Superior Town Code Section 2-2-4(F) POWERS AND DUTIES OF THE MAYOR and by A.R.S. §26-311 to declare an emergency; and NOW, THEREFORE I, Mila Besich, Mayor of the Town of Superior, and the Town Council of the Town of Superior by virtue of the authority vested in them by the Constitution and Laws of the State, specifically A.R.S. §§ 26-311 and Superior Town Code Section 2-2-4(F), do hereby Proclaim and Order: 1. The Town of Superior abides by all Executive Orders of the Governor of Arizona. 2. "Face Covering" as used in this Declaration means either: a. a face mask fabricated to cover the nose and mouth or b. cloth face covering which covers the nose and mouth and is large enough to be secured under the chin and kept on the face hands-free with either loops or rubber bands over the ears or can be tied or looped to the back of the head. Cloth face coverings should be made of a tight-weave-fabric and be folded or sewn to have more than one layer. c. a bandana or similar cloth. 3. Emergency Declarations 2020-01 and 2020-02 are hereby repealed. 4. Emergency Declaration 2020-03 is modified as follows: a. The public shall not be allowed to enter the Town of Superior Government buildings or facilities, including open space areas, without a Face Covering. B. Face Coverings are not required: i. When being in Town Parks or Town Trails; ii. When being at public events; iii. At sporting events; iv. When swimming at the Town Pool; 5. All other sections of Emergency Declaration 2020-03 are repealed. 6. # Shop at Home: Casa Dona Lola

In April 2020, COVID-19 brought much of Arizona's economy to a screeching halt. All businesses not deemed "essential" were ordered closed by Arizona's governor Doug Ducey.

The lockdown continued for nearly two months. When Gov. Ducey finally gave the go ahead to reopen, businesses slowly began the road to recovery. Even those listed as "essential" had a challenge with this economic recovery.

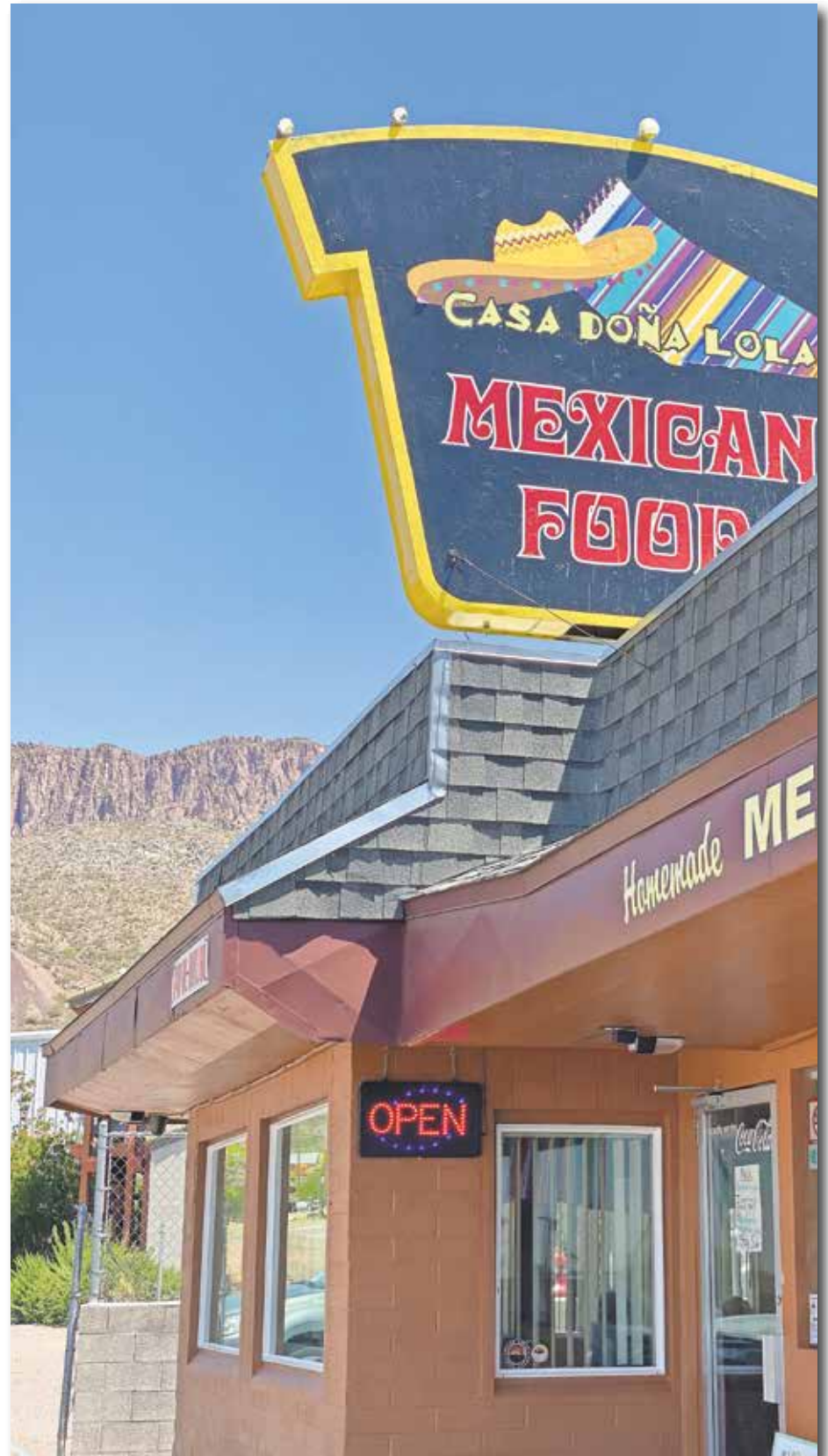
Many small businesses and non-profits in Arizona didn't survive the lockdown. The businesses that did survive are hanging on as best they can. *Copper Area News* wanted to give something back to the local business community. Over the next several weeks, our newspapers (*Copper Basin News*, *Superior Sun* and *San Manuel Miner*) will be featuring local businesses and non-profits, encouraging our readers to Shop at Home, stay local and support our local businesses. To date, *Copper Area News* has featured 54 businesses in the Copper Corridor.

Restaurants were the some of the hardest hit businesses during the pandemic. When the first wave of shut downs occurred, restaurants were forced to limit their

business to take out only; dine in options would not be allowed. Like most of the restaurants in Superior and the Copper Corridor, Casa Dona Lola pivoted through the chaos and kept their doors open for take out. They even began using the take out window that had been used decades ago when their building was occupied by the Hamburger King.

Casa Dona Lola offers a variety of traditional Mexican food favorites, enchiladas, tacos, chimichangas and burros. Unique menu items include Nopales, which are actually the pads of the Prickly Pear cactus, the Lola's favorite dinner plate includes a pork chop topped with nopalitos in Lola's special red sauce and Molcajete which is a dish with steak, chicken, shrimp, green chili, onion and whole beans. They also have a breakfast menu and daily specials.

You can find Casa Dona Lola on the southeast corner of Belmont and US 60 (649 US Highway 60). They offer dine in and take out.
