


Angel T. Marin



Their second game of the week was against the Ray Bearcats, where they faced an extremely close loss.

"The game versus Kearny was uncharacteristic of Superior softball," commented coach Alfonso Lopez. "We had 11 errors in the game, allowing seven runs."

McKenna Duarte once again had a good day at the plate going 1-2 with a triple that brought in two players. Mikayla Cruz went 3-4 with two doubles bringing in two players as well. The Lady Panthers scored

four runs in the seventh inning, falling short by one run, with a final score of 6-7.

RESOLUTION NO. 2021-637 A RESOLUTION OF THE MAYOR AND COUNCIL OF THE TOWN OF SUPERIOR, ARIZONA, DECLARING AS PUBLIC RECORDS THOSE AS PUBLIC RECORDS THOSE CERTAIN DOCUMENTS FILED WITH THE TOWN CLERK AND ENTITLED EXEMPTIONS FOR SINGLE FAMILY RESIDENTIAL DWELLINGS AND MANUFACTURED /MOBILE HOMES WHEREAS, Revised Statutes §9-802 provides for the adoption of a code or public record by reference; and WHEREAS, The Town Council has determined the adoption by reference the Town Code Article 12-3-4
Exemptions for Single Family Residential Manufactured/Mobile Homes will be beneficial to the health. safety and welfare of its citizens; and WHEREAS, it is the purpose of this Resolution to declare the Town Code Article 12-3-4 Exemptions for Single Residential Dwellings Manufactured/Mobile International Residential Code 2018 in the Town of Superior, Arizona; to be public records for the purpose of adoption and ENACTMENTS: reference; Article 12-3-4 Exemptions for Single Family Residential Dwellings and Manufactured/Mobile Building Permit Required 1. It shall be unlawful to erect, construct, reconstruct, alter or use any structure or building without first obtaining a building permit from the Town of Superior; except that no building/use permit shall be required for not exceeding \$1,500 dollars (market value labor and materials or actual receipts for cost of materials can be provided) except that those items listed in exempted from permit requirements for single family residential dwellings and manufactured/mobile homes. 2. For non-residential uses a permit is required regardless of the dollar value of the improvement when there are applicable building code requirements. 3. For the purpose of determining the value of any such repair, alterations, or improvements the normal retail value of materials and labor performed shall be used. Even though no permit is required for repairs or improvements having a certain value or listed below, such repairs, improvements or alterations shall comply with all other provisions of IRC2018 4. Reestablishment of a discontinued nonresidential use shall not require a permit for the same use, provided that the discontinued use was established through the permitting process in place at the time of establishment, and that no new construction is proposed. B. Work Residential Dwelling and Manufactured/ Mobile Home Only. 1. Re-roofing (when no structural changes are proposed or any reinforcement is required to add heavier roofing materials), re-siding or replacement of exterior trim. 2. Replacing or adding gutters or downspouts. Replacing or adding soffit, gable, or roof

ventilation. 4. Replacing existing windows or doors with no structural changes. 5.



Decks less than 30-inches in height above the lowest grade within 5-feet of deck edge. 6. Replacing like for like or repairing existing plumbing fixtures such as toilet, tub, sink, garbage disposal, water heater, or faucets. 7. Replacing existing appliances or internal light fixtures. 8. Replacing like for like or repairing existing furnace, air-conditioner, cooler, heat pump, or heater, 9, General systems, subject to water conservation requirements, and retaining walls up to 4-feet in height. 10. Replacing cabinets or countertops. awnings supported by an exterior wall which do not project more than 54-inches. Swings and other equipment accessory to a single family dwelling. 20. Water Tanks supported directly on grade if the capacity does not exceed 5,000-gallons and the ratio of height to diameter or width does not exceed 2:1. 21. One-story detached accessory structures provided the floor area does not exceed 200-square feet and has no utilities. Floodplain regulations may apply. 22. Shade cloth structures constructed for nursery or agricultural purposes, not including service systems. 23. Temporary motion picture, television and theater stage sets and scenery. 24. Oil derricks, 25, Electrical; a) Repairs and the replacement of lamps or the connection of approved portable electrical equipment to approved permanently installed receptacles. b) Radio and provisions of this code shall not apply to electrical equipment used for radio and television transmissions. c) Satellite dishes and residential antennas for wireless communications. d) Temporary testing systems: A permit shall not be temporary system required for the testing or servicing of electrical equipment or apparatus, e) Reinstallation of branch circuit overcurrent devices of the required capacity in the same location. f) Electrical wiring, devices, appliances, apparatus or equipment operating at less than 25 volts and not capable of supplying more than 50 watts of energy. 26. Gas: a) Portable heating appliance b) Replacement of any minor part that does not alter approval of equipment or make such unsafe, c) Portable fuel-cell appliances system and are not interconnected to a

It is unlawful to erect, construct, reconstruct, maintain, use, or change the use of any land in any Zoning District in violation of any regulation or any provision of this or any ordinance pertaining thereto, and any such violation constitutes a public nuisance. E. A developer shall not circumvent the permit requirements of this article by making improvements, renairs or alterations which constitute a complete unit through piecemeal or phased construction with the intent to avoid these permit requirements. F. If it is otherwise exempted project, the applicant shall only be charged for any necessary inspections and plan reviews. The lockdown continued for nearly two months. When Gov. Ducey finally gave the go ahead to reopen, businesses slowly began the road to recovery. Even those listed as "essential" had a challenge with this economic recovery.


Many small businesses and non-profits in Arizona didn't survive the lockdown. The businesses that did survive are hanging on as best they can. Copper Area News wanted to give something back to the local business community. Over the next several weeks, our newspapers (Copper Basin News, Superior Sun and San Manuel Miner) will be featuring local businesses and non-profits, encouraging our readers to Shop at Home, stay local and support our local businesses. To date, Copper Area News has featured 54 businesses in the Copper Corridor.

Restaurants were the some of the hardest hit businesses during the pandemic. When the first wave of shut downs occurred, restaurants were forced to limit their business to take out only; dine in options would not be allowed. Like most of the restaurants in Superior and the Copper Corridor, Casa Dona Lola pivoted through the chaos and kept their doors open for take out. They even began using the the take out window that had been used decades ago when their building was occupied by the Hamburger King.
