Arizona Independent Redistricting Commission seeking public input on new Legislative and Congressional District boundaries; Pinal County event set for July 23

The Arizona Independent Redistricting Commission (IRC) invites residents to participate in its first round of statewide public hearings beginning July 23 and continuing through Aug. 9, 2021. Information will be presented both in person and virtually about the redrawing of Arizona’s congressional and legislative districts. Public comment received during these meetings will be used by the IRC to help inform the drawing of new district boundaries. Commission Chair Erika Neuberg urges all Arizonans to attend one of these important hearings to ensure their voices will be heard.

Over the next few months the Commission will be making decisions about Arizonans’ future voting districts. Voting districts determine what district a resident will vote in for representation in the United States Congress and the Arizona State Legislature. Redistricting is necessary as it takes into account any population changes

from the last ten years and creates districts of equal population.

Arizona voters passed Proposition 106 in the 2000 General Election, amending the Arizona Constitution to create a five-member commission to redraw congressional and legislative district boundaries based upon census

data. The IRC is made up of two Democrats, two Republicans and an independent Chair elected by the other commissioners. The chair must not be a member of either party already represented on the Commission. Proposition 106 replaced the old process in which

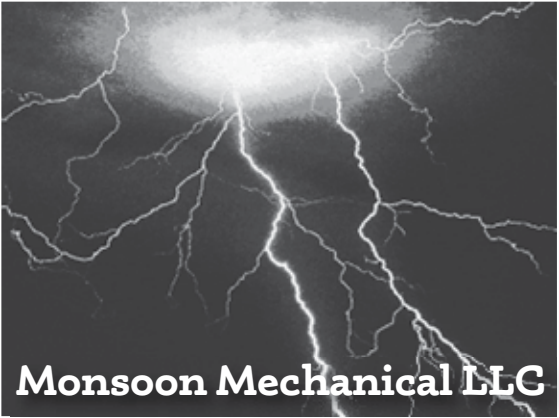

More Arizona communities are leveraging brownfields grants to revitalize blighted properties statewide

More Arizona communities are leveraging brownfields grants to revitalize blighted properties statewide. Brownfields grants help municipalities and nonprofits identify and reduce environmental hazards, mitigate public health threats, create new business opportunities, increase tax revenues and restore impacted properties to beneficial reuse.

Each year, communities across the nation compete for limited federal brownfields grant funds. Common brownfields projects involve redeveloping main streets to boost tourism and community services, creating additional greenspaces and adding healthcare facilities. The Arizona Department of Environmental Quality (ADEQ) both administers a state-level Brownfields Assistance Program to provide brownfields grant funds and helps municipal and nonprofit applicants prepare successful federal grant applications.

ADEQ awarded \$414,000 in brownfields grants in fiscal year 2021 to support these accomplishments:

- The Lowell Observatory (Flagstaff) assessed and cleaned up existing buildings as they overhaul the site to optimize both their manufacturing functionality and visitor experience.
- Gila County removed lead and asbestos from an abandoned building in Hayden adjacent to a former Brownfields site. Together, the two properties were revitalized into a rest stop with picnic tables that overlook the area.
- San Carlos Apache Tribe removed an asbestos-filled building at the Cutter Airport, which is looking to expand and grow.
- City of Show Low cleaned up asbestos and lead from the former junior high school, which repurposed the existing structures to provide community services.

ADEQ’s Brownfields Assistance Program also funded completion of seven

environmental assessments that helped to identify hazardous waste and building material that can be translated into cleanup projects for fiscal year 2022.

“As our Brownfields team continues to support more municipalities and nonprofits to address local environmental issues, together we are completing impactful projects that protect Arizonans’ health and provide lasting economic benefits for our communities,” said ADEQ Director Misael Cabrera, P.E.

“Even during the pandemic, 12 Arizona communities successfully continued work on brownfields projects,” said ADEQ Brownfields Coordinator Travis Barnum. “This is a testament to our small and rural communities’ resourcefulness and resilience.”

“Gila County is excited to receive this funding as it will enable us to enhance our efforts towards combating blight in our smaller communities and unincorporated areas,” said Gila County Supervisor Woody Cline.

Recently, the U.S. Environmental Protection Agency (EPA) awarded an additional \$2.95M in brownfields grants to communities in Apache, Gila, Navajo, Pinal and Yuma counties, as well as to the Salt River Pima Maricopa Indian Community and Navajo Nation.

“For many years leaders from throughout Arizona’s Copper Corridor have been struggling to combat blight, we are finally making significant improvements thanks to the support and grants through the Arizona Department of Environmental Quality,” said Mayor Mila Besich from the Town of Superior. “The award of the Regional EPA Brownfields grant will increase our opportunity to improve the health and safety for our communities, while also creating new opportunities for economic growth for Superior and Arizona’s Copper Corridor region.”

Do Your Part: Conserve Water

After wildfires, drivers should be wary of potential for storm runoff; ADOT says expect the unexpected, possible highway closures

PHOENIX – This monsoon season could prove to be especially disruptive to travel plans after a series of major wildfires has made burn areas susceptible to flooding. That can leave highways covered with mud and other hazardous debris.

Anytime drivers are traveling this summer, the Arizona Department of Transportation is urging drivers to expect the unexpected, including unscheduled closures, near recent burn areas and to take extra precautions.

ADOT crews are prepared to respond to storms and are already working to minimize flood damage. To promote faster response times, crews are moving heavy equipment from storage yards closer to areas susceptible to damage. Also, trucks are being fitted with plows to patrol areas for mud, rocks and boulders or other debris. State highway maintenance crews have been clearing debris to prevent heavy rains from clogging washes or other drainage systems that flow near or under highways.

ADOT’s preparation and future responses are being coordinated with other government agencies, including the Arizona Department of Public Safety, emergency management agencies, the National Weather Service, the U.S. Forest Service, fire responders and local governments. The planning includes sharing information about which areas are most vulnerable to erosion and flooding, along with developing response plans to reopen roadways after storm damage.

While the risk of flooding or sudden closures can occur anywhere wildfires have occurred in recent years, some areas are especially vulnerable this summer. Those highways include US 60, SR 77 and SR 177, where the Telegraph Fire has caused widespread damage on roadways forming a triangle between Superior, Globe-Miami and Winkelman.

Storm damage is also possible because of fires in 2021 or recent years on highways that include SR 88, SR 188, US 191 south of Alpine, SR 87 south of Payson and SR 260 between Camp Verde and SR 87.

“We’ve been clearing debris along highways and drainage systems even before some wildfires are out to minimize flood damage, but the work is ongoing,”

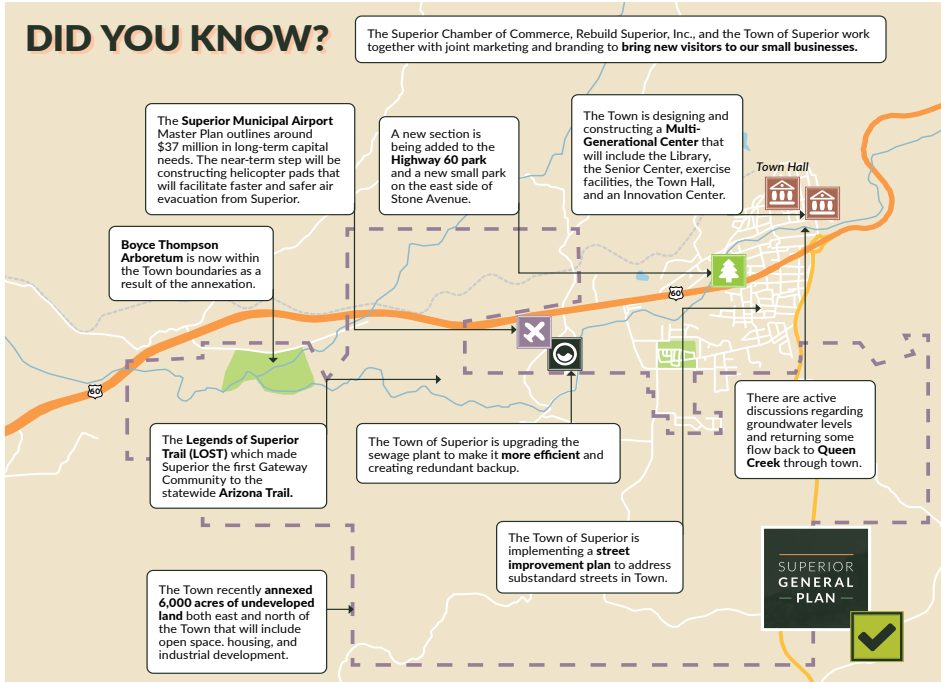

said Kurt Harris, assistant district engineer for ADOT’s Southeast District, who has overseen multiple responses to flood-damaged highways. “We want drivers to be ready for potential rock falls or flood closures, and most importantly to

plan ahead this summer to avoid frustrating delays or detours.” While seasonal advice applies to traveling during the monsoon, ADOT asks drivers to pay extra attention this year while traveling near burn areas:

- Check ADOT for road conditions and closures. Updated information is available at AZ511.gov, through our Twitter or Facebook pages as well on the ADOT Alerts app.
- Know the weather. Check National Weather

Service forecasts before traveling and during breaks, keeping in mind summer storms often pop up in the afternoon and evenings.

- Consider delaying travel. If it’s raining near a recent fire scar, it’s best to stay put because even light rains can lead to flooding on recent burn scars. Storm runoff into drainage systems or washes can leave some low spots along highways subject to flooding and debris deposits.
- Take nighttime precautions. Darkness can obscure boulders, standing water or other hazards. Don’t travel faster than what you can safely brake or see with your headlights.
- Sudden highway closures are possible. Because the problem could range from an isolated rockfall

to widespread damage, extended closures are possible.

- Expect summertime highway restrictions. Crews will be working along highways to replace guardrail, clear debris along roadways or repair other damage resulting from fires or storms.

geographical features, respect for communities of interest and potential competitiveness. The state Constitution requires the commissioners – two Republicans, two Democrats and an independent chairperson – to start from scratch rather than redraw existing districts.

A new Arizona Independent Redistricting Commission was appointed in January 2021 to adopt new congressional and legislative districts for Arizona.

JOB SUMMARY:

Under general supervision of the Town Manager, plans, directs and manages the functions of the Public Works Department including all municipal infrastructure and the divisions of engineering services, building/parks/street maintenance, water/wastewater, equipment mechanical activity, regulatory compliance, solid waste, effluent reuse and building safety/inspections.

ESSENTIAL FUNCTIONS:

- Provides supervision and training for assigned staff.
- Responds to emergency situations as necessary, schedules staff to cover after-hours emergency and on-call duties on a rotating basis.
- Develops a department budget and controls expenditures.
- Evaluates needs and formulates short and long range plans to meet needs in all areas of responsibility including building inspection/safety, transportation, streets, sewer, drainage, lighting, building/parks/cemetery maintenance, rights-of-way, and environmental compliance.
- Supervises the review of private project development plans for compliance with codes, regulations and standards, adequacy of applications for permits and compliance with approved plans.
- Oversees the functions of the building safety and inspection division.
- Oversees the functions of the equipment maintenance division.
- Develops and implements the Town’s Capital Improvement Plan, and other programs involving the municipal infrastructure.
- Determines applicable codes, regulations, and requirements for assigned projects.
- Monitors intergovernmental actions affecting public works.
- Oversees the preparation of engineering plans and specifications, bidding, competency of contractors and vendors and the selection criteria for public contracts.
- Responds to public works or other inquiries related to departmental policies and procedures. Evaluates issues and options regarding municipal public works issues and makes recommendations.
- Develops and reviews policies and procedures for emergency and disaster management.
- Interviews, hires, promotes, transfers, schedules, assigns, evaluates and rewards work performance. Assists in the training of public works personnel including safety and OSHA compliance.
- Oversees project management for the construction of municipal projects. Oversees assigned projects to ensure contractor compliance with time and budget parameters for the project.
- Maintains regular contact with consulting engineers, construction project engineers, Town, City, County, State and Federal agencies, professional and technical groups and the general public regarding division activities and services.
- Provides technical assistance to staff and inspects and evaluates work being performed to ensure standards are met; identifies problem areas and directs remedial action; personally responds to inquiries and complaints from the public.
- Ensures structural integrity of the wastewater collection system and environmentally sensitive wastewater collection, treatment and reuse.
- Ensures compliance with chemical handling standards; detects toxic gases, oxygen levels and a variety of other parameters.
- Ensures maintenance, repair and efficient operation of a wide variety of motors and pumps, electrical and electronic components and control valves association with the system’s storage reservoirs, pump stations and related facilities.
- Works with State and federal regulatory agencies, such as the Arizona Department of Water Resources, Arizona Department of Environmental Quality,

and the US Environmental Protection Agency to ensure compliance with all areas of water quality.

- Performs other duties as may be assigned from time to time.

KNOWLEDGE, SKILLS AND ABILITIES:

- Knowledge of the principles and practices of effective administration with particular attention to planning, organizing and directing comprehensive, administrative and management services;
- traffic laws, ordinances and rules involved in equipment operation;
- hazards and safety rules and regulations involved in operating heavy equipment;
- methods, practices, techniques and equipment used in operating large, complex water treatment facilities;
- federal, state, county and local laws pertaining to the operation of water treatment facilities;
